Suppose that...

- ... Team A does score a goal in the 14th minute. This is scored by S. Beckmann (number 26), assisted by K. Müller (number 5). The scoring player number have to be registered in the two left columns.
- ... In the second half, S. Beckmann playing number 26 is substituted by L. Meerscho playing number 8. Substitutes minute 22 "Beckmann out Meerscho in".
- ... In the 24th minute B. Anta playing number 22 scores a goal from a penalty stroke. Again, this is registered in the left columns. Of course, in this case, no assist was given.
- ... In the 27th minute Beckmann comes in again and Meerscho goes out. This is registered under Substitutes "In / out".
- ... In the 39th minute H.Hansson scores a goal, but without any assist. Again, this is registered in the left columns.
